LOS ALTOS HILLS

Welcome to the home of the future. Built by James Parivash, this two-level modern abode is controlled by voice and by app. Featuring six bedrooms, six full baths and two half-baths in the main house—plus a well-equipped pool house—the home's main level contains floor-to-ceiling windows with sweeping views of San Francisco, Oakland and Palo Alto.

The large kitchen includes two islands and a large double-door fridge, while each bedroom generously contains an en suite bath. The lower level acts as an entertainment center, and contains the spa—which has a sauna and other spa amenities—fitness center, theater, office and wine cellar, plus three bedrooms.

Outside, homeowners can enjoy the large infinity pool with a cabana and bath, while the attached four-car garage comes equipped with charging stations.

PORTOLA VALLEY

This impressive five-bedroom, seven-bathroom contemporary home not only offers a master class on jaw-dropping design but one on sustainability as well.

Recently completed, the net-zero property offers a slew of Earth-friendly features, including four Tesla Powerwalls for off-grid operation and automatic backup power, geothermal heating and cooling and 124 solar panels. With a combined 10,233 square feet—encompassing the interior space, garage and terrace—on 2.61 acres of land, the Jay Jeffers-designed estate is grounded with European oak hardwood and French limestone flooring and contains glass walls that seamlessly integrate indoor-outdoor living while providing stunning views from the San Francisco Bay to the foothills.

Homeowners luxuriate in numerous extras, including a wine cellar, a home theater and an in-home fitness center. Conveniently located near grocery stores and shops, for safety, the home is equipped with a surveillance system that monitors nearby traffic.
